MAIL ALL RENEWAL DOCUMENTS TO THE ADDRESS ABOVE.

(It is highly recommended that you submit your re-certification packet at least 60-90 days prior to your expiration date to provide ample time for processing. Sending your packet using a mail service that provides delivery confirmation is also recommended, as ACS is not responsible for lost or undelivered mail.)

PLEASE KEEP A COPY OF YOUR PACKET FOR YOUR RECORDS.

Continuing education criteria:

- All CEU's must be related to the Core of Knowledge requirements for your facility type. (http://ccld.ca.gov/res/pdf/Core.pdf)
- Up to half of the required CEUs may be completed via interactive online courses.
- CEU's may currently be completed through taking applicable courses:
 - Approved by the California Department of Social Services. (See our website at http://ccld.ca.gov/PG559.htm for approved training vendor contact info.)
 - Provided by Department of Developmental Services Regional Centers (for GH and ARF administrators only).
